SUMMARY OF MATTERS TRANSACTED

Item		Summary
1.	Covid-19 Industry Recovery Plan	The Committee received an update on the Industry recovery plan, including BCD racing during the second lockdown and ongoing liaison with Government to develop a pathway for the return of crowds.
2.	Previous Minutes	The minutes of the meetings held on 27 July, 20 August and 30 September were approved.
3.	Horse Welfare Board	The Committee received an update on the progress of HWB activities and the implementation plan. The Committee endorsed the HWB paper and agreed the general approach to next steps, including agreement to support funding applications to the Racing Foundation and Levy Board. A meeting between the HWB and Funders would be arranged as a first step.
4.	Wellbeing Strategy	The Committee received a presentation and noted the background to the development of the Wellbeing strategy and the experience of Racing Welfare in supporting the needs and requirements of the industry's workforce. The Committee endorsed the report, accepted the proposals, and agreed to proceed with the formation of a Wellbeing Board and implementation plan.
5.	Community Engagement	The Committee received an update on the development of the Community Engagement Directory. The Committee empowered the existing Steering Group to explore ways to better serve racing's community engagement work through the 'Racing Together' brand by working with Racing to School to revisit their purpose and structure.

6.	Diversity & Inclusion	The Committee received an update on the industry's diversity and inclusion framework. The Committee agreed that, subject to further consideration of objectives, the Member organisations would progress the overarching commitment to diversity and inclusion and publish a collective statement in due course.
7.	Pattern & Listed Race Programme 2021	The Committee considered a proposal for support for Pattern and Listed races, which focussed on the importance of maintaining international competitiveness. The Members confirmed support for the general direction of travel subject to further evidence and more detailed work from the Fixtures and Funding Group to outline potential options for the way forward.
