

**Whip Review Committee**  
**Decisions 11 June 2024**

On Tuesday 11 June 2024 the Whip Review Committee convened to consider potential breaches of Rule (F)45 following referrals from the racecourse Stewards and their own independent review of races for races run from 6 June – 9 June 2024, inclusive. A summary of their findings is outlined below.

**Haydock Park 7 June 2024**

**Race 1 – The Betfred 'Bet Builder' Amateur Jockeys' Handicap Stakes (Class 5)**

Miss Stephanie Dorey, the rider of the winner, SISTERANDBROTHER, was found to have used her whip without giving her mount time to respond on two separate occasions. She will be suspended for 7 days as follows: Tuesday 25, Thursday 27, and Friday 28 June, and Monday 1, Friday 5, Saturday 6, and Sunday 7 July.

**Goodwood 7 June 2024**

**Race 4 – The William Hill Extra Place Races Apprentice Handicap Stakes (Class 5)**

Kaiya Fraser, the rider of the winner, NEVER DREAM, was found to have used his whip once above the permitted level of six from one and a half furlongs out. Allowing for the fact that Fraser has had over 100 rides in Great Britain since a previous whip breach, mitigation on penalty was applied. Therefore, he will be suspended for 3 days from Tuesday 25 to Thursday 27 June inclusive.

**Bath 7 June 2024**

**Race 5 – The betting.bet Horseracing Odds Handicap Stakes (Class 5) (Bath Summer Stayers' Series Qualifier)**

Nicola Currie, the rider of BATTLE OF OMDURMAN, placed second, was found to have used her whip twice above the permitted level of six from inside the final two furlongs. She will be suspended for 7 days from Tuesday 2 to Monday 8 July inclusive.

**Chepstow 8 June 2024**

**Race 1 – The Download The vickers.bet App Handicap Stakes (Class 6)**

Jack Doughty, the rider of ALFRED COVE, placed fourth, was found to have used his whip once above the permitted level of six from two furlongs out. He will be suspended for 4 days from Tuesday 25 to Friday 28 June inclusive.

**Race 6 – The Best Odds Guaranteed at vickers.bet Everyday Handicap Stakes (Class 6) (Chepstow Mile Series Qualifier) (Div I)**

Gina Mangan, the rider of KENSTONE (FR), placed third, was found to have used her whip three times above the permitted level of six. She will be suspended for 10 days from Tuesday 25 June to Thursday 4 July inclusive.

**Beverley 8 June 2024**

**Race 7 – The Bet Boost a Bet365 Handicap Stakes (Class 6)**

David Allan, the rider of EVELYN'S PHOENIX (FR), placed second, was found to have used his whip once above the permitted level of six from inside the final furlong and a half. He will be suspended for 4 days from Wednesday 3 to Friday 5, and Sunday 7 July.

## **Catterick Bridge 8 June 2024**

### **Race 1 – The Pennine Brewing Company Restricted Maiden Fillies' Stakes (Class 5) (For Horses in Bands C And D) (GBB Race)**

Mark Winn, the rider of ASINARA, placed second, was found to have used his whip without giving his mount time to respond. He will be suspended for 4 days from Tuesday 25 to Friday 28 June inclusive.
