

### **Whip Review Committee Decisions 2025:**

On Tuesday 19 August 2025 the Whip Review Committee convened to consider potential breaches of Rule (F)45 following referrals from the racecourse Stewards and their own independent review of races run from 14 August 2025 – 17 August 2025, inclusive. A summary of their findings is outlined below.

#### **Chepstow 14 August 2025:**

Race 1 - The dragonbet.co.uk 'Training Series' Apprentice Handicap (Part Of The Racing Excellence Series) (Class 6)

Jay MacKay, the rider of the winner PUNCHBOWL FLYER (IRE), was found to have used her whip excessively down the shoulder in the backhand for encouragement with her hands on the reins from inside the final furlong. She will be suspended for 4 days from Tuesday 02 to Friday 05 September 2025, inclusive.

#### **Windsor 14 August 2025:**

Race 3 - The Racing League Race 24 Handicap (For horses In The Care Of Trainers Registered To Racing League) (Class 4)

Jack Dace, the rider of the winner KODI FIRE (IRE), was found to have used his whip twice above the permitted level of six from two and a half furlongs out. He will be suspended for 7 days from Saturday 13 to Friday 19 September 2025, inclusive.

#### **Epsom Downs 15 August 2025:**

Race 4 - The Betfred Play Fred's £5 Million Handicap (Class 6)

Morgan Cole, the rider of the winner HUGGABLE, was found to have used her whip once above the permitted level of six from approximately two furlongs out. She will be suspended for 4 days from Tuesday 02 to Friday 05 September 2025, inclusive.

#### **Great Yarmouth 15 August 2025:**

Race 2 - The Claire And Michael's 25th Anniversary Classified Stakes (Class 6)

Pierre-Louis Jamin, the rider of the winner CAESARS PEARL (IRE), was found to have used his whip once above the permitted level of six from approximately two furlongs out. Allowing for the fact that Jamin has had over 200 rides in Great Britain since his previous whip breach, mitigation on penalty was applied. He will be suspended for 2 days, Tuesday 02 and Wednesday 03 September 2025.

Adam Farragher, the rider of PAYFORANOTHER DAAY, placed third, was found to have used his whip three times above the permitted level of six from approximately three furlongs out. He will be suspended for 10 days from Tuesday 02 to Thursday 11 September 2025, inclusive.

**Doncaster 16 August 2025:**

**Race 4 - The Quality Freight Services Handicap (Class 5)**

Gianluca Sanna, the rider of RENEWABLE DREAM, placed third, was found to have used his whip three times above the permitted level of six from inside the final three furlongs out. He will be suspended for 10 days from Tuesday 02 to Thursday 11 September 2025, inclusive.

Kevin Stott, the rider of HARSWELL RUBY (IRE), placed second, was found to have used his whip once above the permitted level of six from approaching the final furlong. He will be suspended for 4 days as follows; Tuesday 19, Sunday 31 August, Monday 01 and Tuesday 02 September 2025.

**Market Rasen 16 August 2025:**

**Race 5 - The PricedUp.Bet Boosts Handicap Hurdle (Class 4).**

Conor Ring, the rider of HALIFAX (FR), placed second, was found to have used his whip once above the permitted level of seven from turning into the home straight. He will be suspended for 4 days from Thursday 04 to Sunday 07 September 2025, inclusive.
